100.01 SCOPE.

The provisions of this chapter are intended to apply to property owners and persons connecting to the Villages Sewer system.

100.02 SEWER CHARGES, ASSESSMENTS, AND CAPACITY FEES.

(a) There is hereby levied and assessed upon each lot, parcel of land, building or premises having any sewer connection with the sanitary sewer system of the Village, or otherwise discharging sewage or industrial waste into the Village sanitary sewage system, a capacity fee, late fee, collection fee, and a sewage service charge or rental, payable on a monthly basis in amounts determined by the Village Council through appropriate legislation.

(b) Pursuant to subsection (a) hereof, the billing for customers of the Village of Hanover for sewer services based on Equivalent Residential Units (ERU) shall be as follows:

Example:

1 ERU = \$ 50.00/month
Commercial User = 3 ERU's
3 ERU's x \$50.00 = 150.00
Commercial User Monthly Flat Fee = \$ 150.00

MHP = 1 ERU/trailer
20 Trailers = 30 (min) ERU's x \$50.00 = \$1500.00/month

35 Trailers = 35 ERU's x \$50.00 = \$1750.00/month

(c) Pursuant to subsection (a) hereof, the sewer late and collection fees for customers of the Village of Hanover sewer system, payable either with the late monthly bill and/or at the time of collection through property taxes to the Village of Hanover sewer department, shall be as follows:

Late Fee

<u>Type / Class</u>	<u>Fee / Month</u>
All Classes	\$ 10.00

All classes shall be assessed a late fee when over 30 days of the date due on the normal bill.

Collection Fee

<u>Type / Class</u>	<u>Fee / Collection</u>
All Classes	\$ 200.00

All classes shall be assessed a collection fee along with the accumulated late fees if the Village has to go through collection procedures with the County Tax Department.

(d) Pursuant to subsection (a) hereof, the sewer capacity fees for customers of the Village of Hanover sewer system, payable at any time prior to the issuance of a Village of Hanover Building Permit if required, shall be as follows:

(e) Pursuant to subsection (a) hereof, the sewer capacity fees for residential homes in foreclosure within the Village of Hanover shall be as follows:

FOR FORECLOSED PROPERTY NOT CONNECTED TO VILLAGE SYSTEM

1. The new owner will catch up all past due payments or a pay the \$5000.00 capacity fee, which ever is less
2. The new owner will pay to have the sewer installed to his residence.

FOR FORECLOSED PROPERTY CONNECTED TO VILLAGE SYSTEM

1. Starting from the time of legal ownership, the new owner will be responsible for the class of the monthly bill going forward.
