**FISCAL OFFICER REPORT:**

Gieseler reported:

- Insurance Claim- grandmother made the teen pay for crosswalk repairs. Money was submitted to our insurance company and the insurance company sent it to us.
- ARPA reporting is finished for 2021.
- SRTS/STP Plan- Jim Lenner will assist under 2022 grant service retainer. Initial meetings and application.
- Water- Kevin Eby sent a weekly update. Arcadis has been selected to perform the Preliminary Engineering Report/Feasibility Study for Hanover and Marne. The county is in the process of entering into an agreement with them. Arcadis completed the feasibility study for the City of Newark. Gieseler will attend water project meetings to insure the village has the opportunity to hear first hand results, process, discussion, input and feedback.

- Utilities Corridor- Jim Lenner will send Johnstown’s plan so we can review and work toward applying our own.
- Impact Fees and Housing Design Standards- Information is being gathered for our consideration of evaluating and implementing.
- OPWC- Clarify concerns with Phase 3 application submission. Submitting the application in 2023 and beginning construction in 2024, with full payment starting in 2025 was suggested from a financial standpoint. Timing with other project may cause the start date to be different, ultimate timing rest with council. Engineering will still be applicable pending any changes. Last municipal bond payment is scheduled for the end of 2024. In 2025 we can go out for an additional municipal bond to pave the rest of the village.
