PLANNING & DEVELOPMENT:

President Dave Molnar reported:

- LCATS: traffic count date is being set.

- 217 Clearview Drive has removed 2 vehicles, 40 tires and 2 loads of scrap metal. Asking for additional time.

- Mayor Collins met with Richard Waugh. 150K allocated toward match money for projects needed within the county. 1K over the next 5 years. Waugh also announced his resignation.

- BPA is holding a meeting with RCAPS to discuss sewer expansion
- Hanover Vol Fire Dept contract will expire at the end of this year. Legislation will begin this fall.
- Scott Ryan will be attending our Sept 14 P&D and Council meetings to discuss Intel.
- Water Project: Commissioner Flowers attended July 21st school board meeting to provide an update. Superintendent Scott Beery has been invited to participate in planning calls along with Jack Shinn. July 25th water project team meeting took

place. In Phase 1 mainline will go up Licking Valley Rd and will end near gas station in Hanover. E. High St will be addressed in Phase 2.

STREET COMMITTEE REPORT:

- Paving of W. High Street was discussed. Christian is clarifying project date with the county. LAW General will be doing a site review of areas that need patched and crack fill.
- Ditches need mowed on Colby Way. This should be taken care of by property owner.
- W. High St/ Main Street intersection stop bar was discussed along with the potential for re-locating.
- Address change needs completed for Rine building on Clearview Drive.
- Recap of storm damage from the past week. Trees down, roads closed, traffic lights out.

STORM WATER REPORT:

Councilor Pierce reported:

- Resonant Drive ditch was evaluated. Could get ADR's opinion on how to mitigate.
- Storm basin behind Meadow Drive and near Darla Drive that is impacting Don Flowers home on Meadow Drive is being evaluated.
- Hale noted that SWPPP plan for Hainsview Ph 5 has not been followed. Erosion and silt control needs monitored, ADR will assist in the future and cost will be passed through to the developer. Also obtained a list of inspectors from ODOT. Inspection must take place to pass MS4 standards. ADR will evaluate Meadow Dr condo's as well.
