- Licking Park District Grant Funding- Jim Lenner has advised that the Park District is willing to give us 5K up front for fence or guardrail along the bike path above the tunnel. Currently getting cost estimates for material and labor.

  Developer is calling Waste Away to mitigate trash issues. Three sewer taps have been paid and three sewer taps need paid.
  Plans are in place to asphalt the driveway this fall.
