## PLANNING & DEVELOPMENT:

- The adoption of Hainsview Phase 5 infrastructure was discussed.
- Proposal from Neighborhood Strategies for Form Based Code zoning regulation updates was distributed.

## ZONING INSPECTOR'S REPORT:

- Properties with zoning violations do not have much further clean up. Will proceed with next step which includes citation from legal advisor.
- Photographs of property clean up progress was requested.
- No new permits received.

## LETTERS AND CORRESPONDENCE:

- LV Financial Task Force meeting attended.
- Rock climbers are making area improvements. Investigation towards finding if village is liable if the village embraces the actions of rock climbers. The City of Newark will be contacted as they have a similar situation on Horns Hill Road.

FISCAL OFFICER REPORT:

- All money is accounted for the month of November and the bank statement has been reconciled.
- SRTS- grant application submitted by Jim Lenner prior to Dec 9<sup>th</sup> deadline.
- Licking Parks- no grant needed. They have placed our need as a 2023 appropriated budget item. New project idea needed. Tree removal and maintenance in park will not qualify as a possible grant application project. A quote is being received from Flowers Land Services for removal/trimming of all necessary trees at the Old Hanover Park and using this toward applying for park funding.
- AEP is trimming trees around Hanover Park shelter house.
- Windstream Forestry will be evaluating trees on powerlines along S. Main Street and accessing for removal/clean up.
- Sidewalk In Kind- waiting for final engineering quote from Environmental Design Group.
- Meeting with a rep from River Rangers tomorrow to evaluate a log jam in the Rocky Fork Creek just south of the Hainsview Phase 5 storm drain pipe.
- Village Christmas tree was delivered on Sunday and was donated by Drew Gibson owner of H5 Enterprises and Jason Carson with Carsons Nurseries. Tree needs decorated.
- Councilor Hale made a motion to send the bills to finance, second by Councilor Flowers, All- Ayes

• Councilor Spaulding made a motion to pay the bills, second by Councilor Renicker, All-Ayes.

FINANCE/CIP REPORT:

- LCATS: Village of Hanover Tip Project is on the books for 2024, match money required by village is 28K.
- OPWC 3: may need to change focus to paving lower part of village. Cost has tripled. Current estimates are around 1 million. May need to use municipal bond to finish phase 3 of W. High Street sidewalk.

BPA REPORT:

- 27 Behind, \$4,295.00 total
- Plant running well.
- Block heater at Life Station requires repair.

GROUND DIRECTOR REPORT:

STREET COMMITTEE REPORT:

• Ok to pay W. High Street paving with the increase cost of 6K. An additional load of asphalt was required to keep edges from breaking down. Hainsview Drive seam will be corrected in Spring to prevent discoloration. Flowers Drive seam also needs addressed.

- Meadow Drive catch basin repair is complete. Additional basin will be complete by end of year.
