PLANNING & DEVELOPMENT:

• Meeting with Jayson Gardner took place regarding ROW expansion of W. High Street. A proposal will be submitted to the village for their assistance with acquisition.

ZONING INSPECTOR'S REPORT:

- Rolls by the Pound signage permits are being evaluated. Tim Pound and Tim Journey were present to discuss the need for a variance. Signage regulation were updated in 2021. Variance will be needed for road sign and menu board. BZA meeting will be scheduled upon receiving the variance application.
- Carl Hains developer of Hainsview Estates would like to move forward with having Phase 5 dedicated to the village. Collaboration will be initiated between village engineer and solicitor to work out the final details.
- Licking Valley School/Spaulding land swap school has been advised of the steps to complete the process.

LETTERS AND CORRESPONDENCE:

• Multiple reports have been filed to the LCSO regarding vehicle and building break-ins.

FISCAL OFFICER REPORT:

- Ordinance 22-2023 is being added to the agenda this evening. This legislation creates the opportunity for the village to participate in RITA's non-filling program. The last participation was in 2019. At that time there were 112 non-filling letters sent out and 74 subpoenas. Liabilities identified \$7,429, Collection \$4,704. The cost is \$1 per subpoena. Emergency vote is suggested as paperwork was just received and needs returned by June 1 and there is not another council meeting scheduled between now and June 1.
- River Round Up participation is needed for our MS4 compliance. Project chair and volunteers are needed.
- Sunoco is requesting the villages approval of submitting a TREX application to apply for a D6- Sunday Sales, C1-permission to sell beer sealed and C2- permission to sell wine and mixed beverages sealed. The current D1 permit attached to the property was transferred to Players Pizza. Councilor Wright made a motion to approve the submission of the TREX application, second by Councilor Pierce. Vote by roll call- Hale- Yes, Wright- Yes, Pierce- Yes, Renicker- No, Spaulding- No, Flowers-No. Tie vote- Mayor Yes. Motion moved to approve the submission of the TREX application to apply for a D6, C1 and C2 liquor permit.

- Developer has advised that leaning light pole on Colby Way has been fixed by AEP.
- Speed limit signs may be needed in Phase 5 upon dedication of streets.
- An article on our village will appear in a publication out of New Jersey called Sister Cities. The column highlights small towns across the USA and what they have to offer. Thank you to resident Leigh Morgan and Angie Cherubini for providing photographs for the article. Time release of the article at the present time is unknown.
- W. High Street Sidewalk Improvement Project: 4 tree removal bids have been received. Cost is between 24K-44K. 27K is allocated within the SIB loan for this project. Legislation is on the table for reading tonight. Councilor Wright recommended Morehouse Tree Service, second by Hale- all ayes.
- Licking Parks Grant- Received MP Dory's quote for labor, the quote from Lynn's General Services has expired. Lynn will be asked for an updated quote before final decision is made.
- Water Project- survey with the ODOD was completed to renew our 2021 application for funding. Funding request will focus on Phase 2.
