## FISCAL OFFICER REPORT:

- Thursday Oct 26 CPIM training in Columbus: focus is Leadership in Public Finance and Economic Development- Specifically the Role of Fiscal Officers in Ohio's Future. Nov 1st Auditor of State Fiscal Officer Training.
- Tyler Flowers reported that he is getting calls on the asphalt cross cut being finished at the condos. Advised paving should take place Nov 1.
- Trees at Meadow Ct will be cut back to allow for sign visibility in all directions.
- Sidewalk Project: Soil spreading should be complete as of today, asphalt driveway forms set in place tomorrow, asphalt on
  Friday. Trees will be planted next week and then final grade clean up seed and straw will be completed by a landscaping co.
  Minerva McArtors residence- down spout drainage that goes under the sidewalk creates a deeper than desired swell, needs
  addressed. Verdantas suggested a 4-inch pipe be extended east to reduce swell and make it easier to maintain. Before
  doing he is getting me a cost for approval.

- Intersection High/ Main: Legislation for current updates to intersection- Signal is required to be removed and replaced with a four way stop. Cost for the entire project should be under 10K. ADR Administration \$2500, signs \$1500 and then MP Dory labor is unknown.
- Legislation on the table tonight to add the intersection update to the MTP listing with LCATS. Project scheduled out for 2030's+
- OPWC Lower Village Paving: project will be broken out into two phases.
   Phase 1 will be \$38,929 out of pocket. This will be paid out in 2024 out of the 2101 Permissive Fund
   Phase 2 will be \$40,965 out of pocket and will be paid out of the 2025 2101 Permissive Fund.
   Total Cost of both project: \$887,889. Total Loan 192K. Total Grant 650K. Total annual loan payment/10 Years: \$19, 200.00.
   To be paid out of our 1% Income Tax revenue. Out of pocket upfront expense will come out of our 2101 Fund. Loan payment will be paid from our 1% Income Tax Revenue. These numbers have been added to our CIP Plan. We had budgeted
- Water Project: Meeting took place with solicitor Stephen Samuels and Kevin Eby. Kevin advised that the county has past the water district resolution last month it will be called "The Licking Valley Water District No. 1". We went through the agreement together and Kevin asked for clarification on a few things. Before agreement can be finalized we need to know each entities contribution, have the rules and rates established, know the cost of bulk water, have a better understanding of customer base and know approx. how much money will need to be on reserve for O & M. Madison Twp contribution will be 250K, the Village 126K and Hanover TWP has not indicated that they will be assisting. All money contributed is ARPA money and not regular tax revenue. Engineering plans are 30% complete. Transmission line is going to the south side of the road. Structurepoint is planning to have 90% plans completed by December. Secondary loop is being planned to insure water availability if service line is breeched. Original cost for Phase 1 \$12M, inflation has caused a project increase of \$1.1 mill, new total is \$13.1M. Additional funding is already being sought by the county to cover the expense most likely in a grant/loan.
- Stormwater Utility: Briefly discuss stormwater utility with solicitor Stephen Samuels. Mr. Samuels indicated based on ORC 3903 he is not convinced that the village needs to be managing the MS4. He wanted to review our MS4 contract with LCSW. Contract was sent for his review. He also indicated that a storm water utility plan is community specific, it's driven by topography, roadside ditches etc and it is difficult to use other entities plan as a template. Creating our own is best.
