# Village of Hanover Council Meeting Minutes June 26, 2024

  - 5. Smalls: Bond received, \$375,929.95, Alternative bid 40,311.80

Licking County Residential Building Codes on the November 5, 2024 ballot for a citizen vote.

#### STREET COMMITTEE REPORT:

- Brimming will be completed on Hainsview Dr in needed sections.
- Mowing completed for parade, street will be swept by the City of Newark.
- Additional signs for "mowing ahead" etc. have been ordered.
- Ditch mowing maintenance discussed along W. High St. Mowing will be completed three times a year: prior to Memorial Day, July 4<sup>th</sup> Parade and Labor Day.

#### STORM WATER REPORT:

- Residents were present from Hainsview Phase 5 to discuss ditch solutions provided by ADR & Associates. Ron Bonnet from ADR & Associates addressed the public with an explanation as to why the rock could not be in the ditch without the proper grade. Rock size impacts slope. Concerns noted from residents as follows: rocks were approved by past admin and developer, topsoil was removed from property prior to lots being sold and new land owners were unaware of additional expense this would cause, some residential lots do not have topsoil and are not finished with proper grading which impacts drainage, the expense to try to make lots functional has created unexpected financial hardship and the request to modify ditch will cause additional financial burden, if rocks are removed the sand/rock base will not permit grass growth, natural stream is full of construction trash (one resident reported spending \$10K to remove 14 truckloads of development construction debris), rocks were placed to correct an existing problem if removed the drainage problem will not be resolved, sump pumps are being directed into front ditches so there will always be water, ditches have not been altered on lots that have not been built and they hold water, were ditches inspected, development plans called for 16 inch culverts and permits called for 12 inch culverts and 12 inch were installed by contractors- who is responsible for this, Jon Green has a lot with a second driveway that has no culvert, retention pond placement questioned, are the ditches in question because of a residents concern with mosquitos.
- A council vote was taken to move forward with addressing a repair now or postponing until development is completely built out. Council members voted to move forward with repair now: Wright-Yes, Vogel-No, Spaulding-Yes, Renicker-Yes, Cost-Yes, Pierce Absent.
- Mayor Hale advised that the ditches are required to meet the EPA plans that were approved. The Village Solicitor has advised that the village is responsible for paying for engineering cost to complete ditch inspections on the residential lots. The village will move forward with having each lot inspected and surveyed for modification recommendations.

Ordinance 13-2024 An Ordinance authorizing and directing the Mayor to execute a contract with ADR & Associates, LTD for engineering services required to develop a Storm Water Analysis of Areas 3 and 4 within the village on behalf of the Village of Hanover, Licking County, State of Ohio. -second Reading.

# **NEW/OLD BUSINESS**

Mayor Hale presented an opportunity for all to speak:

Councilor Cost: tree growing around light pole at 2294 W. High St. and Eric Drive. Village was reviewed for outages. List was
created for AEP and Energy Co-op. Numbers on poles are becoming illegible, nearby address is not always applicable.
 Councilor Wright will request new pole tags from AEP.

#### MAYOR'S MINUTE:

• The switch from State Commercial Building Codes to Licking County Building Codes for commercial properties is to pull money back local government from the state. We have been informed that the inspections are the same and therefore there are no changes. The question was asked if the village hall fire station remodel was inspected by the state, answer was no. Once commercial is implemented in the village the turnaround for inspections should be quicker.
