Contract indicates pick up must be after 7:00 am, Licking County Recycling is following up with provider.

 made including brush clean up between park, swapping out old mobile homes for new and offering residents free WIFI.

- Phase 5 Ditch survey and inspection: discussion took place regarding survey results. Area evaluated with ADR. Two categories created, one- obvious problems, two- minor but potential future problems. Many issues stem from the installation of improper culverts. Development plans dictate what size to install and size depends on location of parcel. Improper culverts will need replaced. Considerations also include but not limited to: grading, sloping, aggregate, LCSW assessment, and changes to future evaluations which may include builders to submit an engineered stamp storm plan or site plan for parcel. Once final report is made from evaluation of Phase 5, Council will have to decide on how to move forward.
- Hains Hill Drainage Repair- project is set to begin upon completion of sidewalk update.
