PW Report: Tyler Flowers

- Sink hole repair at Maple Lane and Clearview around the catch basin. Concrete poured inside and outside of the culvert to seal. New asphalt was also put down. No further signs of settling.
- Resident complaint of a washout on Hickman Rd. Corrected and built a berm up on the side of the road to correct future water flow.
- Licking Valley Bus Garage complaint of limbs hitting bus on Clearview. Tree limbs cleared and hauled away. Still more that needs done but will wait until further information on tree grant.

- Also made aware of limbs hanging out in the road in Hainsview, will also be taken care of in next few days.
- Met with Village Engineer, Sam Eppley, Curtis and Layton on Hains Hill project. They are
 going to make corrections to fix water pulling. Suggested from Tyler and Sam they need to redo all of the erosion. Sam confirmed today that Layton is going to make corrections but still
 narrowing down a start date.
- Met with Village Engineer, Sam Eppley at the Event Center to address flooding. The swell that
 could be put in and can be done but will not stop flooding that occurred during the July storm.
 Reviewed ditch in front of parking lot. The ditch needs to be cleaned out and the culvert needs
 to be cleared.
- Several areas that need birming done. Suggested getting a large load in and use as needed.
 Material used would be 304 and 411's.
- Spoke with Jim Lenner regarding tree grant details. Will need to get various items such as cones, signs, etc. The Village will need to consider safe and secure storage.
- Grates for the detention pond in phase 5 are ready and just need to be installed.
- Following up on if updates or changes will be made to zoning on pools of water such as ponds.
 Jim Lenner confirmed the zoning code does list fencing required around ponds. Suggested making an amendment to remove that as the reality of 18inch is not doable.
- Per the acceptance of Phase 5 agreement with developer from 2023, sewer infrastructure review will be coordinated with Eric Dr and Hains Hill Dr sewer pipe camering.

Ordinance:

- Ordinance 31-2025 OPWC Hainsview Pipe Washout: An ordinance authorizing Brandon Hale,
 Mayor to prepare and submit an application to participate in the Ohio Public Works
 Commission State Capital improvement and/or local transportation improvement program(s)
 and to execute contracts as required and declaring it an emergency. Councilor Wright made a
 motion to waive the second and third reading, second by Councilor Cost. Councilor Vogel
 made a motion to adopt, second by Councilor Pierce. Vote by roll call: Pierce-Yes, Wright-Yes,
 Vogel-Yes, Cost-Yes, Renicker-Yes, Spaulding-Yes.
- Ordinance 32-2025 Fee Schedule: An Ordinance revising the Fee Schedule on behalf of the Village of Hanover, Licking County, State of Ohio and declaring an emergency. Councilor Vogel made a motion to waive the second and third reading, second by Councilor Cost. Councilor Wright made a motion to adopt, second by Councilor Spaulding. Vote by roll call: Pierce-Yes, Wright-Yes, Vogel-Yes, Cost-Yes, Renicker-Yes, Spaulding-Yes.

New/Old Business:

- Jim Lenner informed Council the Rural Tribal Grant is open and due September 8th. They have increased the max amount up to 2.5 million. The Neighborhood Strategies team has worked to create a plan to spend those potential funds. Asked Council if they would approve going requesting the full amount, all of Council agreed.
- Neighborhood Strategies confirmed ODNR Tree Grant submitted today, 08/27/25. Should know by early October if the Village will be awarded any of those funds.
